Operation Power Play 2019: Statewide Exercise

How did it start?

Joint Venture 2013 was a pioneering effort led by ComEd that sought to test disaster response capabilities following the challenging 2011 storm season and lessons learned from our 2012 response to Super Storm Sandy

How much has it grown?

Interest has grown over the years by almost 300%.

Why does this exercise matter?

- Operation Power Play is the largest Statewide Exercise in the Nation developed and led by a private sector utility
- Operation Power Play allows representatives from public, private, state, and federal agencies to work together <u>before</u> an emergency
- Private / Public Partnership working together with governmental agencies to prioritize resources and understanding capabilities
- Participating agencies showcased their emergency response equipment and commodities (base camps/temporary reporting centers, command vehicles, etc.)
- Operation Power Play helps municipal, County, and State agencies understand organizational response processes and test their own







ComEd's experience

- Key takeaways:
 - Addressing opportunities within our Cyber response process and how it ties to our ICS structure
 - Our JOC Municipal Portal requires additional testing
 - Feasibility of using our new Emergent Resource Management System (ERMS) to bring Mutual Assistance (MA) crews onto property
 - Specific examples/relationships
 - Discussions around use of covered, heated vehicle parking options with IDOT and the IL National Guard
 - Improved MA communication with Ameren and MidAmerican Energy
 - Work on the Regional Resiliency Assessment Program with Cybersecurity and Infrastructure Security Agency (CISA) (DHS/FEMA)





First evers for this exercise

- Cyber attack scenario 5 organizations participated
- Testing/developing a singular statewide command structure and data sharing capabilities for aviation operations
- Over 25 real and virtual drone, fixed wing, and rotary wing flights
- Mock joint press conference
- Use of Virtual SIMCELL developed by Argonne National Laboratory
- On site blood drive with local blood bank, Vitalant
- Exceeded 300 injects issued by the SIMCELL; does not include internal injects



Operation Power Play federal support

<u>Federal involvement in Operation Power Play:</u>

- Helped close operational and response gaps experienced by many agencies during an emergency
- Provided invaluable expertise, aiding in streamlining response processes across sectors
- Showcased the cross-sector/agency interest in supporting the residents of the State of Illinois and unified efforts to provide them support when a disaster strikes

- Manpower and resource sharing between Regions, States
- Open discussions surrounding:
 - Data sharing during emergency response
 - Joint aerial operations and damage assessment restrictions
 - Travel waiver processes and provision
 - Connected infrastructure across Regions, States vulnerable to Cyber attack
- Benchmarking between Regions, States about organizational best practices


